In consideration of the undersigned being permitted to exhibit at the Antiques on 48 Outdoor Markets it is hereby agreed that:

- I shall have my exhibit ready no later than 9.15 am on Saturday - event runs 10 am - 6 pm Saturday & Sunday, 10 am - 5 pm on Monday.
- For the long weekend pop up markets, I shall have my exhibit removed no later than 6:00 pm on Monday. Early pack up Monday allowed.
- For the Labour Day Weekend Outdoor Market, I shall have my exhibit removed no later than 7:00 pm on Monday. Early pack up Monday allowed.
- I shall set up my exhibit so that there is no permanent damage to the area.
- There will be no liability for loss, damage, or injury, other than which is held be each dealer. Each dealer is responsible for acquiring their own insurance if deemed necessary.
- No security will be provided overnight. The driveway will be closed off overnight.
- Written cancellation must be made to Antiques on 48.
Antiques on 48 will retain a **\$25.00 cancellation fee.**
